

## POLICY on ENHANCING UAE NATIONAL IDENTITY & CULTURE

(Excerpts from His Speech on the occasion of the thirty-sixth anniversary of the founding of the UAE.)

#### Introduction

The UAE National Identity refers to the sense of belonging and allegiance that concerns the citizens of the United Arab Emirates, and the residents living on its territory alike.

It is a system of social and moral values associated with the lifestyle of the people in the past, present and future. Enhancing the National Identity is a matter of National , religious, past, future , collective and individual commitment to the Promoting and enshrining these elements is a collective and individual commitment to the cultural, values customs , traditions, language, dialect , doctrine and faith of the UAE as a nation. Promoting and enshrining these elements is a collective National duty incumbent upon the community, individuals, government and institutions.

The National Identity is based on six pillars through which it is possible to realize the main objective of protecting and preserving that Identity and strengthening and consolidating its presence in the community.

#### I. The Staff

They shall see to it that the contents are aligned to the existing curriculum of the school. The co-curricular activities shall always be associated to the lesson or occasion. The school designates the led staff that will be responsible for the monitoring & reporting. All staff and management of this school are required to involve in this undertaking.

## IV. Student Participation

• The school shall ensure that students are fully aware of this policy on enhancing the National Identity & Culture and apply to their real life.

#### V. Evaluating Success

This school policy will be kept under regular review. In addition, evidences will be gathered regarding:
